6) Brief facts leading to the appeal

6.1) On 17/07/2019 this Appellant submitted a request for information, to the CPIO, mentioned at **para** #2 above, along with the prescribed application fee, through the RTI Online Facility, stating as follows (**Annexe 1**):

"I would like to obtain the following information pertaining to the Electronic Voting Machines (EVMs), Voter Verified Paper Audit Trails (VVPATs) and Symbol Loading Units (SLUs) supplied by your company for use during the recently concluded General Elections to the Lok Sabha, under the RTI Act:

- 1) The maximum number of votes recordable on each EVM supplied for use in the 2019 Lok Sabha Elections,
- 2) The maximum number of votes printable on each VVPAT Machine supplied for use in the 2019 Lok Sabha Elections,
- 3) The district-wise number of Control Units of EVMs transported across India for use in the 2019 Lok Sabha Elections,
- 4) The district-wise number of Ballot Units of EVMs transported across India for use in the 2019 Lok Sabha Elections,
- 5) The district-wise number of VVPATs transported across India for use in the 2019 Lok Sabha Elections,
- 6) The district-wise number of thermal paper rolls used in VVPATs transported across India for use in the 2019 Lok Sabha Elections,
- 7) A clear photocopy of the List of Engineers with name and designation, deputed for carrying out tasks relating to the preparation of EVMs and VVPATs that was sent to every District Election Officer in India for the purpose of the 2019 Lok Sabha Elections,
- 8) A clear photocopy of the List of Senior Level Engineers with name and designation, deputed for supervision and coordination during the preparation of EVMs and VVPATs that was sent to every District Election Officer in India for the purpose of the 2019 Lok Sabha Elections,

- 12) A clear photocopy of the User Manual prepared by your company, pertaining to the SLUs used during the 2019 Lok Sabha Elections, if any,
- 13) A clear photocopy of the application filed with the Office of the Patent Controller for securing a patent on VVPAT, if any, along with the postal address of such office, and

- 14) A clear photocopy of the application filed with the Office of the Patent Controller for securing a patent on SLU, if any, along with the postal address of such office."
- **6.2)** On 17/06/2019 the CPIO of this Public Authority sent this Appellant a reply to the instant RTI application, stating *inter alia* as follows (**Annexe 2**):

- **6.3)** Subsequently, on 18/07/2019, this Appellant despatched by Speed Post, a bank draft for Rs. 1,434/- along with a covering letter to the CPIO mentioned at **para #3** above stating that the fee is being paid **without prejudice** to this Appellant's right to submit a first appeal against the CPIO's reply rejecting access to the information sought at Query #13 of this instant RTI application (**Annexe 3**).
- **6.4)** After waiting in vain for more than a month for the copies of documents that the CPIO mentioned at **para** #3 above had agreed to supply, this Appellant submitted an appeal on 28/08/2019 to this Hon'ble First Appellate Authority (FAA) via the RTI Online Facility with the following prayers (**Annexe 4**):

"This Honourable Appellate Authority may be pleased to:

- 1) admit this appeal and inquire into the matters raised herein, and
- 2) direct the CPIO to furnish all the information sought in the instant RTI application free of charge."

This Appellant adduced multiple grounds in support of his prayers which are included in Annexe 4. This Appellant is eagerly awaiting the decision of this Hon'ble FAA on the said first appeal.

6.5) Meanwhile during the pendency of the said first appeal, on 02/09/2019, this Appellant received a revised reply from the CPIO mentioned at **para #3** above returning the bank draft and stating as follows (**Annexe 5**):

7) Prayers or relief sought

This Appellant prays that this Hon'ble First Appellate Authority be pleased to:

- 1) admit this appeal and inquire into the matters raised herein;
- 2) club the present appeal along with the initial appeal already submitted on 28/08/2019 for the purpose of issuing a combined decision; and
- 3) direct the CPIO to furnish information sought all the information that he was initially prepared to furnish, free of cost as is this Appellant's right under Section 7(6) of the RTI Act;

8) Grounds for the prayer or relief

8.1) According to Section 19(1) of the RTI Act, any person who is aggrieved by the decision of the CPIO may prefer an appeal to the officer senior in rank to such CPIO within 30 days of the receipt of such decision. This Appellant received the revised reply of the CPIO of this Public Authority on 02/09/2019. This first appeal is being filed on the 8th day of the date of receipt of the CPIO's revised reply, which is well within the limitation period mentioned in

Section 19(1) of the RTI Act. This Appellant is aggrieved by the decision made by the CPIO of this Public Authority for reasons explained below:

- 8.1.1) The revised reply sent by the CPIO mentioned at para #3 above, is perplexing when examined in the light of his initial reply. The said CPIO's initial reply constituted, primarily, a demand for payment of the copying charges as per fee rates prescribed under the RTI Rules, 2012 against most of the information sought in the instant RTI application save the reply provided against Query #13. This Appellant's appeal against the said CPIO's reply to the information sought at Query #13 already stands submitted to this Hon'ble Appellate Authority. So this Appellant does not intend to repeat those arguments here in order to prevent wastage of the time of this Hon'ble Appellate Authority. However, the CPIO's revised reply to Queries #3-6 and 11 contained in the instant RTI application seems to indicate that he is under pressure from some agency- external or internal to this Public Authority, to not supply this information. No other conclusion is possible given the detailed reply that the said CPIO furnished initially. He had calculated the exact number of pages containing the information described in the said Queries of the instant RTI application. This clearly indicates that all that information was physically available with the said CPIO at the time of determining the fee payable for supplying this information. So the said CPIO's revised reply against information sought at Queries 3-6 seems at first glance to be misleading and false. Providing false or misleading information is a valid ground for demanding and imposing penalty against a CPIO under Section 20(1) of the RTI Act. This Appellant reserves his right to demand such action against the said CPIO at a later stage, if necessary. However, this Appellant would like to afford this Public Authority one opportunity to correct its erroneous action by submitting this first appeal. Hence the submission of this appeal to this Hon'ble First Appellate Authority.
- **8.1.2)** Further, even if it the CPIO of this Public Authority were to contend that the information sought at Queries #3-6 were not physically available with him at the time when the bank draft for Rs. 1,434/- was delivered to him, under Section 6(3) of the RTI Act, the CPIO has a duty to transfer those parts of the RTI application to the concerned public authority that holds that information in material form. However, the said CPIO has not elected this course of action either. Instead he has merely stated that the requested information is not available with this Public Authority. The said CPIO has resiled from his statutory duty required to be performed as per Section 6(3) of the RTI Act. **Hence the submission of this appeal to this Hon'ble First Appellate Authority.**
- **8.1.3)** Further, the CPIO of this Public Authority initially, made a determination that the information sought at Queries #7-8 were fit to be disclosed. Nothing in his revised reply indicates as to how he has arrived at the opinion that disclosing the names of Engineers who were tasked with preparing the EVMs and VVPATs and those Senior Engineers who supervised these tasks would endanger their life and physical safety. What circumstances have come to pass in a period of one month from the date of the initial reply of the said CPIO, that these categories of information have suddenly acquired a very high degree of sensitivity is not indicated in his revised reply. Clearly, the said CPIO is under pressure from some agency- external or internal to this Public Authority to not disclose this information.

Further, in several quarters, both internal and external to the country, the 2019 Lok Sabha Elections have been hailed to be a successful exercise without much doubt being raised about their freeness or fairness. There is no conceivable reason why the names of the Engineers may not be disclosed or such disclosure should endanger their life or physical safety. It is this Appellant's firm belief that the CPIO of this Public Authority has prevaricated in his revised reply. Therefore his reply deserves to be set aside. Hence the submission of this appeal to this Hon'ble First Appellate Authority.

- **8.1.4)** Further, the reply of the CPIO of this Public Authority against Query #11 of the instant RTI application is not only perplexing but also contradictory. In his initial reply he had agreed to supply this information on payment of additional fees. However in his revised reply he has first claimed an exemption and then stated that the VVPAT User Manual is available on the website of the Election Commission of India, in addition to stating that ECI holds copyright over such Manual. This Appellant has not sought any VVPAT Manual that is already published on the ECI's website. Instead, he has sought the User Manual that Engineers of this Public Authority have used during the Lok Sabha Elections. That Manual is not available on the ECI's website. This confusing and contradictory reply clearly indicates that the said CPIO has not adequately applied his mind to the queries or is under some pressure- external or internal to this Public Authority to not disclose this information. **Hence the submission of this appeal to this Hon'ble First Appellate Authority**.
- **8.1.5)** Further, the CPIO of this Public Authority has not sent any revised reply against Query #12 of the instant RTI application pertaining to the User Manual for Symbol Loading Units (SLUs). To the best of this Appellant's knowledge the VVPAT Manual uploaded on the ECI's website does not contain detailed instructions for Engineers to operate the SLUs. The CPIO has not bothered to check his facts before sending his revised reply. This indicates a lack of due application of mind on the part of the CPIO. **Hence the submission of this appeal to this Hon'ble First Appellate Authority.**
- **8.1.6)** Further, according to Section 7(6) of the RTI Act, where a CPIO fails to provide the information sought in an RTI application within the time limit specified in Section 7(1) of the RTI Act, the RTI applicant is entitled to receive all the information free of charge. Should this Hon'ble Appellate Authority decide that any or all of the balance information sought in the instant RTI application ought to be furnished to this Appellant, this Appellant believes that he is entitled to receive it free of charge as more than 30 days have lapsed since the submission of the instant RTI application to the CPIO of this Public Authority. **Hence the submission of this appeal to this Hon'ble First Appellate Authority.**
- **8.1.7)** Further, this Appellant tried to submit this appeal through the RTI Online Facility. However, the said Facility reacted that the initial first appeal had already been submitted in the instant case (**Annexe 6**). *Hence the submission of this appeal in hard copy to this Hon'ble First Appellate Authority.*
