- 5) A clear photocopy of any document containing details of action taken to ensure that the pending RTI applications submitted under Section 6(1) and pending appeals submitted under Section 16(1) of the J&K RTI Act do not lapse despite the repeal of the said Act as they are in effect actions taken

exercising the fundamental right to information deemed to be guaranteed under Article 19(1)(a) of the Constitution.
