<p>Prayer or Relief Sought</p> <p>Prayers:</p> <p>This Honourable Appellate Authority may be pleased to:</p> <ol style="list-style-type: none"> 1) admit this appeal and inquire into the matters raised herein, and 2) direct the Central Public Information Officer (CPIO) to disclose all the information described in the instant RTI application, free of charge, under Section 7(6) of the RTI Act, 2005. <p>Grounds:</p> <ol style="list-style-type: none"> 1)The instant RTI application was submitted to this Public Authority through this very RTI Online Facility on 08/06/2020. The 30-day deadline for the PIO to send a reply lapsed on 08/07/2020. This appeal is being submitted 22 days after the lapse of the statutory deadline which is well within the time limit of 30 days stipulated in Section 19(1) of the RTI Act. At the time of submitting this appeal, the said RTI Online Facility continues to show the status of the instant RTI application as- Request Forwarded to CPIO. 2) According to Section 7(1) of the RTI Act, upon receiving a request for information that is held by his public authority, a CPIO has only two courses of

action open to him. He is required to either furnish the requested information on payment of the additional fee as per prescribed fee rates or reject the request for any of the reasons specified in Sections 8 or 9 of the Act. The CPIO cannot sit endlessly on the RTI application without sending any response to the RTI applicant. This Appellant has not received any reply from the CPIO of this public authority, till date.

4) According to Section 7(2) of the RTI Act where a CPIO fails to send a response to an RTI application within the time limit specified in Section 7(1) of the Act, it shall be deemed that the information sought has been refused. According to Section 19(1) of the RTI Act, a citizen may submit a first appeal to the designated First Appellate Authority when his RTI is deemed rejected under the provisions of the statute. These grounds are also attracted in the instant case.

5) According to Section 7(6) of the RTI Act, where a CPIO fails to furnish the requested information within the time limit of 30 days specified in Section 7(1) of the RTI Act, the RTI applicant is entitled to receive such information free of charge. Further this Appellant had requested that all information specified in his RTI application be disclosed suo motu on the website of this public authority with written intimation of the respective URLs to him by email. The CPIO does not appear to have taken this course of action either.

Hence the submission of this appeal to this Honourable Appellate Authority.
