1. Antigua and Barbuda: Information Commissioner's Office

Information Commissioner: Mr. Alister Thomas – served as Deputy Director, Culture and was Chairman of the Sir. V C Bird Centenary celebrations committee.

2. Australia: Information Commissioner's Office

The Information Commissioner's office in Australia comprises of the following officers:

Australian Information Commissioner: **Prof. John McMillan Ao** – served as Commonwealth Ombudsman (Australia) and as Australia's first Integrity Commissioner. He is Emeritus Professor of the Australian National University and was a public lawyer for 3 decades.

Freedom of Information Commissioner: **Dr. James Popple** – has a doctoral degree in artificial intelligence and law. He served as First Secretary in the Attorney General's office earlier.

Privacy Commissioner: Mr. Timothy Pilgrim – has a Bachelor's degree in Arts from Sydney University. Earlier he held senior management positions in Australian Government agencies.

3. Australia: Office of the Information Commissioner (Northern Territory)

Information Commissioner: Ms. Brenda Monaghan – is a qualified barrister and solicitor. She was Judicial Registrar of the Darwin Magistrate's Court and later Legal Member of the Northern territory Licensing Commission.

4. Australia: Office of the Information Commissioner (Queensland)

The Office of the Information Commissioner comprises of the Information Commissioner, the Right to Information Commissioner and the Privacy Commissioner. The Right to Information Commissioner is currently the acting Information Commissioner.
