ORDER OF THE APPELLATE AUTHORITY ON THE APPEAL BY
SHRI VENKATESH NAYAK UNDER SECTION 19 (1)
OF THE RIGHT TO INFORMATION ACT, 2005

1. WHEREAS, Shri Venkatesh Nayak vide application dated 17 Jan 12, had sought following information under Right to Information Act 2005 :-

(a) A clear photocopy of the latest version of all " Lists of Do's and Don'ts" for army personnel issued under the Armed Forces (Special Powers Act), 1958.

(b) A clear photocopy of all standard operating procedures, instructions, guidelines, circulars and office memoranda issued in relation to the implementation / enforcement of all the provisions of the Armed Forces (Special Powers Act) 1958.

(c) A clear photocopy of the latest version of all " Lists of Do's and Don'ts" for army personnel issued under the Armed Forces (Jammu and Kashmir) Special Powers Act, 1990 and

(d) A clear photocopy of all standard operating procedures, instructions, guidelines, circulars and office memoranda issued in relation to the implementation / enforcement of all the provisions of the Armed Forces (Jammu and Kashmir) Special Powers Act 1990.

2. AND WHEREAS, DDG RTI, the CPIO at Integrated Headquarters of MoD(Army) had not provided information as the application was under process.

3. AND WHEREAS, aggrieved by non receipt of any response from the FiO at Integrated Headquarters of MoD (Army), Shri Venkatesh Nayak preferred an appeal dated 07 Mar 12, under the provisions of section 19 (1) of the said Act, stating that he has not received any information as requested vide his application dated 17 Jan 12.

4. AND NOW THEREFORE, after having perused all the records and after hearing views of the nodal officers, I direct DDG RTI to provision extract of Para 2 and 3 of DGMO /MO-2 note No A/20008/1/MO 2 dt 27 Feb 12 alongwith its enclosures and extract of Para 2 of ADG (D&V)/HR Cell note No C/17732/C/RTI/AG/Gen/HRC dt 28 May 12 to the appellant.

5. The appeal is therefore accordingly disposed off.
