Appellate Order

I, Vijay Agrawal, Director (Coord), Department of Defence, Ministry of Defence and appellate authority in the case have gone through the appeal filed by Shri Venkatesh Nayak, B-117, 2nd Floor, Sarvodaya Enclave, New Delhi-110017.

Brief facts of the case:

The applicant vide his RTI application dated 23-12-2011 had requested Central Public Information Officer, Ministry of Defence, New Delhi-110011, certain information on total 3 points. The RTI application was transferred by Shri Rajesh Choudhary, Under Secretary (Coord) & CPIO to other CPIOs for providing the requisite information to the applicant directly vide ID no. 21(1)/2011/D(Coord)-Vol.II (34) dated 05-01-2012 with a copy of letter to the applicant. The US D(GS-IV) & CPIO and the US D(Est.I/ Gp.I) & CPIO informed to applicant that the requisite information does not come under their purview.

Subsequently, Shri Rajesh Choudhary, Under Secretary (Coord) & CPIO had given certain information on point no. 3 of RTI application to applicant vide letter dated 24.02.2012.

The applicant, Shri Venkatesh Nayak has now preferred an appeal vide letter dated 24-02-2012 and received on 01-03-2012, to provide the information requested by him in original RTI application.

Decision on the Appeal:

I have gone through the appeal, the original RTI application and the reply given by CPIOs.

The information on point no. 1 and 2 relates to D (GS-V)-Pak in the Ministry of Defence. Hence, the information on the same may be provided to applicant directly by US D (GS-V)-Pak & CPIO, Shri Inderjeet Sethi. In respect of point no. 3, though Shri Rajesh Choudhary, Under Secretary (Coord) & CPIO had provided certain information to applicant vide letter dated 24-02-2012, the complete information may be provided by him to applicant.

The appeal is disposed off accordingly.

Since the appellate authority was awfully busy and pre-occupied with certain very important works, the appeal could not be disposed off within a period of 30 days. However, the appeal is being disposed off within the limitation period of 45 days from the date of receipt of appeal in the said exceptional circumstances.
