

The Assam Govt. have requested for the deployment of the Army in Gossaigaon (Kokrajhar District); Bijni (Chirang District) and parts of Dhubri District. The respective Deputy Commissioners have given requisition to the local Army Commanders. The Home Secretary, Assam has written to the Joint Secretary (G), MoD. JS(NE), MHA has also written to the JS(G), MoD in this regard (copy enclosed).

2. It is requested that the concerned units may be directed to deploy urgently in the violence-affected areas. The Ministry of Home Affairs have already deployed 29 Coys and 15 more Coys are being deployed after mobilizing them from different parts of the country. As the movement of these additional Coys will take time, the nearby Army units need to be deployed at once.
